Resolution Adopting a Postsecondary Attainment Goal in Mississippi

Year 2030 and 2035 Goal for Impacting Mississippi's Workforce through Educational Attainment

Title: Ascent to 55%

Purpose: Our goal is to strengthen the quality and quantity of Mississippi's workforce by increasing levels of postsecondary educational attainment among working-age adults. Doing this will both improve the lives of individual Mississippians and contribute to Mississippi's current and future economic health.

Outcome: By 2030, Mississippi will increase the postsecondary attainment of its workforce to 55%. By 2035, Mississippi will increase the postsecondary attainment of its workforce to 60%

Resolution

WHEREAS: The Georgetown Center on Education and the Workforce predicts that, by 2027, 70% of all jobs will require a postsecondary degree or credential; and

WHEREAS: The Southern Regional Education Board *Challenge to Lead* established a goal for states to reach 60% of working-age adults with a postsecondary credential: an associate or bachelor's degree, or a career certificate.; and

WHEREAS: The College Board reports that citizens with postsecondary education lead healthier lifestyles, earn more, pay more in taxes, and are more likely to be employed than those with only a high school diploma; and

WHEREAS: Mississippi's current rate of postsecondary attainment, (a degree, credential or industry certification earned beyond high school) for adults age 25 to 64 is 45.2%, which is lower than the national average of 51.3%; and

WHEREAS: The Education Achievement Council seeks to close achievement gaps and to focus on working-age adults (ages 25 to 64) and on populations traditionally underrepresented in higher education as a result of inequities including but not limited to people of color, adult students, and the economically disadvantaged; and

WHEREAS: Mississippi's postsecondary outcomes are particularly low for African Americans, who earn an associate degree or above at a rate of 26.4%, compared to their White counterparts, who earn an associate degree or above at a rate of 36.4%; and

WHEREAS: The Education Achievement Council is committed to equitable postsecondary outcomes and seeks to close educational equity gaps, where race is no longer a predictor of educational outcomes; and

WHEREAS: The Mississippi Department of Employment Security projects an overall increase in employment growth of 5.2% by 2026, increasing the number of jobs in all industries from 1,153,930 to 1,214,180—for an overall increase of 60,250 jobs; and

WHEREAS: The Education Achievement Council, the stakeholders committed to improving the overall postsecondary attainment rates to meet Mississippi's future workforce needs, is a diverse set of all stakeholder agencies and institutions representing elementary and secondary education, higher education, employers, and industry; and

WHEREAS: Members of the Education Achievement Council are focused on related work within their own organizations and are seeking an increased, coordinated, and unified effort through participation by state leaders; and

WHEREAS: The Education Achievement Council and its workgroups will develop, support, and assess initiatives that strengthen postsecondary policies, practices and programs with a goal to increase the percentage of Mississippi adults who complete a credential of value beyond high school, particularly focused on credentials relevant to Mississippi's current and future economy; and

WHEREAS: The Education Achievement Council taskforce recommends an attainment goal for Mississippi highlighting the imperative to increase the percentage of working-age adults holding a highvalue certificate, college degree, or industry-recognized credential to 55% by 2030 and to 60% by 2035 particularly focused on meeting Mississippi's future workforce needs.

THEREFORE, BE IT RESOLVED, that on this 22nd day of October in the year 2020, the members of the Mississippi Education Achievement Council endorse the postsecondary attainment goal of 55% by 2030 and 60% by 2035 and call on all leaders in state and local government, business, philanthropy, education, and non-profit organizations to support the effort to expand Mississippi's economy by adopting this goal into their individual strategic plans.
